



THENCE South 08 degrees 00 minutes 00 seconds East, along the West line of said Lot 49, a distance of 378.67 feet to an iron rod found for the Southernmost corner of said Lot 49, and a Northern line of Lake Grapevine, said iron rod also being South 44 degrees 34 minutes 51 seconds West, a distance of 322.21 feet from a Corps of Engineers monument B-134A-4;

THENCE along the North line of Lake Grapevine the following calls:

South 44 degrees 34 minutes 51 seconds West, a distance of 209.93 feet to a Corps of Engineers monument B-134A-3;
